- Tickets are for Members personal use and can only be used by the member together with their family, friend or colleague. Don't be tempted to dispose of spare tickets on the day of the match, even to "Genuine Fans"! Tickets for these matches are NOT sold on a sale or return basis.
- In particular, no member may sell or dispose of their tickets to anyone if they are not required for the member's personal use, they should be returned to the Club Secretary. If you are allocated two or more tickets, the Club may want to know who will be accompanying you or who accompanied you to the game and request back the tickets after the game. Keep hold of your tickets for at least a month after the match.
- If any of the Clubs tickets are discovered on the Black market, the RFU may sanction the Club, which may lead to a loss of allocation for the whole club. The culprits will subject to disciplinary action from Preston Grasshoppers.
- Please do not post photographs of tickets allocated to you on social media sites. This has can result in tickets being copied, forged or advertised illegally
